- A. Contract Amendment with Alameda Anesthesia Medical Group to provide Anesthesia services, call coverage and medical direction for SLH, 5 days per week, for the period October 31, 2015 through October 30, 2016 (one year renewal) net increase of \$1,205,322. With this extension and prior contractual commitments to this vendor, the overall obligation (October, 2013 October, 2016), to this vendor will total an amount not to exceed \$3,615,966. - B. Contract Extension with Alameda Inpatient Medical Group, Inc, to provide Hospitalists services at Alameda Hospital, 24 hours per day, 7 day per week, for the period November 1, 2015 through February 29, 2016 (four month extension) net increase of \$233,333. With this extension and prior contractual commitments to this vendor, the overall obligation (May, 2013 February, 2016), to this vendor will total an amount not to exceed \$1,833,333.
